1. Meeting opened by Jim Nelson, Chairperson

- J Nelson —Welcomed Frank Mofflin Manager Community South32, and Derek du Preez Acting Mine General Manager

- J Nelson Apologies noted. Advised no further feedback was received from members who received a letter regarding absenteeism

2. Accept previous minutes & correspondence

3. South32 update by Derek du Preez, Acting Worsley Mine General Manager

- Presented South32's FY2015 results released 24 August:
 - Safety concern a major focus given three fatalities
 - Strong financial performance despite tough operating environment, with the challenging environment set to continue
 - AGM set for November
- In FY2016 South32 will focus on implementing the regional model and further reducing controllable costs

4. Worsley and mine update by Derek du Preez, Acting Worsley Mine Manager

- Presented Worsley's FY2015 results:
 - Reduction in significant incidents was marred by the loss of Colin Whitton
 - Record mined tonnes and 192 hectares of land was rehabilitated
 - Alumina production was below target and costs (particularly energy) were above target
 - The number of community complaints received increased however fewer required modification to operations
 - Local economic contribution and community investment figures provided
- Advised the mine installed new noise suppression and anti-collision technology to vehicles and equipment
- Advised the business is investigating the bagging of drill holes in the State Forest to make sample material easily accessible

Discussed the proposed Mine Information Bay which is to be located on the corner of the turn off to the Marradong site offices

5. Environment update by Holly Main, Acting Health, Safety, Environment and Community Lead

- Discussed Worsley's fauna monitoring programs, including the wedge-tailed eagle nest protection program
- Advised a review of heritage site, Mt Saddleback, is underway involving an anthropologist and Aboriginal Site informants

6. Community update by Amanda Blunt, Worsley Community Relations

- Discussed Worsley's new community investment framework
- Advised the current grant funding round is open until 4 September
- Advised Worsley's volunteer efforts at the Boddington Senior Games
- Advised the 2016 apprenticeships would be advertised in September

7. Membership Review

- Adverts calling for expressions of interest to join the CLC were placed in the July Boddington Newsletters
- 3 re-nominations and 2 new expressions of interest were received
- Current members Greg Marston, Tahnee Forbes and Cathy Schreiber were all re-elected by the committee
- Expressions of interest from Melanie Durack local Land Care Officer, and Vinnie Rajaratnam community member, were accepted by the committee

8. General Business

- Member updates:
 - F Mofflin thanked the committee for welcoming him to the meeting.
 - P Mitcham thanked Worsley for the blasting tour at the mine and acknowledged the effort input by the team to minimise its impacts on the community.
 - G Marston Friends of Reserve held its Annual General Meeting Saturday. It has been working in
 partnership with Mel Durack on State NRM project funding and has agreed to sponsor the projects –
 Tully Bridge Gully eradication of feral weeds, and the eradication of bridal creeper in the Camballing
 Bridge area. Also reported the Friends of Reserves will be taking part in a team building project with
 the Boddington Gold Mine environmental team.
 - D Newman Provided an update on the successful Boddington Seniors Games. Mentioned the Boddington Hospital Auxiliary is seeking funds and community support for a Community Bus.
 - B Dowsett advised the Wandering Annual Fair is 13 September
 - T Collins requested details on outstanding funding acquittals for the Shire so she can follow up.
 Shared information on the government project 'Green Army' which targets youth to volunteer and suggested Worsley could partner with the project this will be followed up by F Mofflin
 - A Blunt advised the Annual Combined CLC Tour is proposed for 24 September. The tour will include
 the mine site and rehabilitation. The tour will be open to other stakeholders such as near neighbours
 and government representatives to ensure enough people are able to attend and the tour go ahead as
 planned.
 - J Nelson advised updated Terms of Reference need to be signed and provided to Worsley.
